

## Paris Tickets Sweepstakes Rules

- a. NO PURCHASE NECESSARY.
- b. Purchase will not increase odds of winning. Winner will be determined by a random drawing conducted by Great Lakes Science Center personnel.
- c. Participants may also enter by mailing entries to: Great Lakes Science Center, Marketing Department, 601 Erieside Avenue, Cleveland, Ohio 44114, Attention: Paris Tickets Sweepstakes. Entry forms may be obtained by calling the Great Lakes Science Center at 216-696-3729.
- d. The drawing will take place at the Science Center on Friday, May 9, 2008.
- e. Registration begins on Saturday, February 9, 2008 and ends on Sunday, May 4, 2008. Entries sent by mail must be postmarked no later than Monday, May 5, 2008 and must be received no later than Thursday, May 8, 2008.
- f. Winner need not be present to win.
- g. Odds of winning depend on the total number of entries received.
- h. All participants must be at least eighteen (18) years of age or older to register.
- i. Winner will be notified either in person immediately (if present at time of drawing) or by mail within thirty (30) days of drawing. Winner has thirty (30) days following notification to claim prize.
- j. Prize can not be substituted or transferred.
- k. If the potential winning entrant cannot be contacted, or fails to claim the prize within the required time period, the potential winning entrant forfeits the prize. The potential winner must continue to comply with all terms and conditions of these rules, and winners' eligibility for the prize is contingent upon fulfilling all requirements included in these rules. Continental will provide Company with an electronic travel certificate(s) ("eCertificate") as indicated below. The eCertificate(s) will specify the number of ER1181 travel credits provided to Company. Each ER1181 travel credit represents a single round-trip ticket. eCertificates/ER1181 credits are not valid for travel and must be exchanged for the actual ticket(s), following the redemption instructions included on the eCertificate. Such tickets will be valid for round-trip, confirmed-space travel on flights operated by Continental or its subsidiaries or operated by other air carriers and marketed as "Continental Express" or "Continental Connection." eCertificates/ER1181 credits are not valid for travel on Continental code-share flights operated by other airlines. eCertificates and ER1181 credits will be issued as follows:

- A. Expiration date: The eCertificate and ER1181 credits issued hereunder, and any tickets issued in exchange for such ER1181 credits, will expire one year from date of issue and will not be reissued or extended for travel after such date.
- B. Reservations must be made directly with Continental via Continental's website, [www.continental.com](http://www.continental.com), or Continental Airlines Reservations. Please note there will be a Reservation Ticketing Service Fee, if the ER1181 travel credits are redeemed through Continental Airlines Reservations. No fee will apply to tickets issued via Continental's Web site, [www.continental.com](http://www.continental.com). Tickets may only be issued by Continental.

- C. Travel pursuant to an ER1181 credit is not eligible for OnePass mileage credit.
- D. Upgrades to First Class or *BusinessFirst* are not permitted under any circumstances, including standby upgrades for OnePass<sup>SM</sup> Elite members or paid upgrades.
- E. The following amenities are not included with the tickets provided hereunder: alcoholic beverages; headsets; non-member use of Continental's Presidents Club<sup>SM</sup> or other airport lounges; merchandise; in-flight air-to-ground telephone calls; and/or any other items not specifically described herein.
- F. ER1181 travel is capacity controlled. Reservations may only be made in the class of service indicated above. If seats are not available in such class, another flight must be selected where such class is available.
- G. An ER1181 is non-refundable for cash, non-transferable, and non-changeable once issued. If lost, it will not be replaced.
- H. All tickets are issued subject to the vagaries of flight variation, work stoppages, and schedule or route changes. Tickets on canceled or delayed flights will be honored on Continental Airlines or Continental Express only.
- I. Certain taxes, fees and charges may apply to ER1181 travel.
- J. Company and/or any recipient of an ER1181 are solely responsible for any tax consequences to the Company or recipient, and for compliance with all governmental reporting and payment requirements.
- K. Company is not permitted to sell ER1181s issued hereunder. Such sale of ER1181s may result in the immediate termination of this Agreement and tickets issued as a result of such sale will be subject to immediate confiscation. Company will reimburse Continental for all losses relating to such sale, including all costs and expenses related thereto.
- L. All travel will be subject to Continental's Contract of Carriage, which is incorporated herein by reference.
- M. Additional terms and conditions may be provided on the eCertificate itself. Company agrees to be bound by such terms, as they relate to the usage of ER1181 travel credits.
